## Background

## How to Participate?

1. Sign up for the Standard Chartered Singapore 5KM Run at <https://singaporemarathon.com/nsc5km>.

3. Look for the National Steps Challenge™ booth at the F1 Pit Building on 8 Dec, between 7.00am – 10.30am.
4. Redeem your exclusive goodie bag by showing us your NRIC for us to verify that you are a National Steps Challenge™ 4 participant.

## Mechanics
