



NATIONAL STEPS CHALLENGE™ SEASON 6 CORPORATE CHALLENGE (HEALTHY WORKPLACE ECOSYSTEMS) TERMS & CONDITIONS

Challenge Overview

- 1. The National Steps Challenge™ is a physical activity initiative by the Health Promotion Board ("HPB") to encourage Participants ("Participants") to be more physically active, every day, anytime and anywhere.
- 2. Corporate Challenge (Healthy Workplace Ecosystems) ("Challenge") is a part of the National Steps Challenge™ Season 6 Corporate Challenge organised for workers of participating Healthy Workplace Ecosystems (HWEs).
- 3. Participants can sign up by downloading the Healthy 365 app from Google Play Store or Apple App Store. Participants will have the option of taking part in the Challenge by tracking their physical activities via a "Preferred Fitness Tracking Device" which can be
 - (a) a HPB-issued fitness tracker; or any compatible fitness tracker; or
 - (b) a compatible fitness app, namely Apple health, or Samsung Health (for Android) on the Participant's phone
- 4. Interested HWEs must register with HPB in order for their workers to be eligible for the Challenge.
- 5. HWEs will compete based on the daily average step count per Participant as per the steps synchronised to the Healthy 365 app.
- 6. The monthly top five HWEs with the highest daily average step count per Participant will be exclusively featured on the Corporate Challenge website. There will not be any cash rewards for the monthly Leaderboard winners.
- 7. In conjunction with the Challenge, HPB encourages HWEs to organise and conduct their own intra-HWE challenge, at the landlords' or managing agents' sole expense and cost. For the avoidance of doubt, HPB assumes neither responsibility nor liability whatsoever and howsoever in connection with any intra-HWE(s), including but not limited to the provision of any prizes or cost subsidy, which may be conducted.

Official Challenge Period

8. The Challenge will officially start on **3 January 2022**, **0000 hours** and end on **17 April 2022**, **2359 hours** ("Official Challenge Period').

Eligibility

- 9. All HWEs are eligible to join.
- 10. Singaporean, Permanent Resident, and foreign workers who are at least 17 years old (based on birth year), and with a valid NRIC or FIN number at the point of registration for the Challenge are eligible to participate.
- 11. If you are an existing participant of LumiHealth, you will have to withdraw from LumiHealth in order to join this Challenge. Do note that withdrawal from LumiHealth is irreversible.

Participation and Fitness Tracker Collection Conditions

- 12. Workers may register for the Challenge on the Healthy 365 app by entering a unique entry code issued to participating HWEs. All entry codes will be provided to the participating HWEs.
- 13. All Participants of the Challenge will automatically be registered for the National Steps Challenge™ Season 6 when registration commences.
- 14. With the exception of Participants who have collected a HPB fitness tracker in Season 5, all other Participants of the Challenge will be eligible for a new HPB fitness tracker this season on a first come, first served, while stocks last basis.
- 15. Each eligible Participant is entitled to only one (1) free fitness tracker.
- 16. HPB's decision on the allocation of fitness trackers to Participants is final. Requests for exchange of different models of fitness trackers or exception to collect more than one free fitness tracker for any one registered individual will not be entertained.
- 17. Faulty trackers including broken straps can be exchanged on a one-for-one basis at our Authorised Service Providers' outlets, HPB's Customer Care Centre, and designated HPB tracker exchange locations by making an appointment through the H365 App. Find out how to make an appointment here.
 - Note: Exchanges are to be done by appointment only. Appointment booking is required for troubleshooting support at our Customer Care Centres. Technical support is available only at Customer Care Centres. All other tracker exchange locations do not provide technical support.
- 18. Participants who had lost their HPB-issued fitness tracker may call <u>1800 567 2020</u> or email <u>stepschallenge@hpb.gov.sg</u> for further assessment and support.
- 19. Once issued, the fitness trackers are non-transferrable and non-assignable.

Rewards

- 20. Participants who actively sync their steps count data into the Healthy 365 app on a weekly basis (once at least every seven days) throughout the Challenge period will earn Healthpoints worth \$2. The overall top ten steppers per HWE will be rewarded with Healthpoints worth \$5. The Healthpoints will be credited into the eligible Participants' accounts after the end of the challenge.
- 21. Participants are not eligible for the earned mechanics and leaderboard prizes of the National Steps Challenge™ Season 6 Corporate Challenge.
- 22. All Participants of the Challenge will be signed up to the National Steps Challenge™ Season 6 and hence be subjected to the earn mechanics of National Steps Challenge™ Season 6. Please refer to the Terms and Conditions of National Steps Challenge™ Season 6 here.

- 23. Participants can earn additional rewards and/or Healthpoints outside the National Steps Challenge™ Season 6 earn mechanics, such as through chance-based gamification, QR-code scanning gamification, backend gamification, or other HPB programmes conducted on the Healthy 365 app.
- 24. HPB reserves the right to modify and/or terminate the rewards at any time at its sole discretion without any further notice to the Participants and/or organisations.

Disclosure of Personal Data

- 25. HPB may share necessary Personal Data with other Government agencies and with the organisations, so as to serve Participants in a most efficient and effective way, unless such sharing is prohibited by law.
- 26. Personal Data will not be shared with non-Government entities, except where such entities have been authorised by HPB to carry out functions on HPB's behalf for which Personal Data has been collected for pursuant to these terms and conditions or for other specific Government services.
- 27. HPB may use the necessary Personal Data for publicity, promotional, liaison, collection of feedback, surveys, advertising and marketing purposes on any media and in connection with any programmes/outreach/initiatives/activities.
- 28. Participants must be responsible for providing complete and accurate contact information to HPB and its organisers. HPB accepts no responsibility for any inability or failure to contact the participants arising from inaccurate or incomplete contact information.

Health Advisory

- 29. Participants with medical conditions or specific healthcare needs should consult with their doctor before engaging in any physical activities.
- 30. Participants should not participate in the Challenge's activities or events if they are not feeling well.
- 31. The HPB fitness trackers are provided as a public service and are meant to provide Participants with information to encourage an active and healthy lifestyle. HPB fitness trackers and compatible fitness tracking devices are intended to provide a close estimation of your activities and metrics tracked but may not be precisely accurate. The HPB fitness trackers are not medical devices and the data provided is not intended to be utilised and/or relied on for medical purposes.
- 32. HPB shall not be responsible, under any theory of liability or indemnity, for any injuries sustained/casualty (to the extent permitted by law) that should arise directly or indirectly from the participation in the Challenge and/or its associated activities or events held by HPB and/or any utilisation or reliance of any data from the HPB fitness trackers.
- 33. Participants shall indemnify and hold HPB harmless its officers, employees and agents from and against all claims of any nature made by any person arising out of or in connection with this Challenge and these terms and conditions.

General Terms and Conditions

- 34. By participating in the Challenge, Participants agree to be bound by and to comply with the terms and conditions of the Challenge, National Steps Challenge™ Season 6, and the Healthy 365 app, which are expressly incorporated herein and can be found at stepschallenge.sg.
- 35. HPB may vary these terms and conditions without notice, discontinue, or withdraw the Challenge and the National Steps Challenge™ Season 6 at any time without any notice or liability to any party.
- 36. HPB reserves the right to change, and/or terminate the Challenge and/or the National Steps Challenge™ Season 6 rewards scheme at any time at its sole discretion without any further notice to the organisations and/or Participants.
- 37. HPB may, in its sole and absolute discretion and without prior notice, replace, change, or substitute any rewards with another of similar value.
- 38. HPB reserves the right to disqualify a HWE or forfeit any rewards if there are reasonable grounds to suspect that Participants have engaged in fraudulent activity to influence the results of the Challenge.
- 39. HPB's decision on all matters relating to the Challenge and the National Steps Challenge™ Season 6 is final and binding on all Participants and participating HWEs. HPB will not entertain any queries with regard to any challenge results and will not be obliged to provide the reason(s) for its awarding decision to a participating HWE.
- 40. HPB reserves the right to conduct random checks, investigate cases of suspected fraud and suspend a worker's participation status during the investigation period. Participants hereby consent to be contacted by HPB and will comply with HPB's request(s) to be interviewed and featured for auditing purposes.
- 41. Without prejudice to any other provision in these terms and conditions, HPB shall not be liable for any expenses, losses, costs damages, liabilities or other consequences of any nature (collectively "Losses") suffered or incurred directly or indirectly by the Participants of the Challenge and the National Steps ChallengeTM Season 6 howsoever caused or arising and without limiting the generality of the foregoing, whether by reason of or on account of any act or omission whether negligent or otherwise on the part of HPB or its agents or employees (to the extent limited by law), even if HPB or its agents or employees are advised of the possibility of such Losses.
- 42. HPB shall not be liable for any injuries sustained or casualty that arises directly and/or indirectly from the participation of the Challenge and the National Steps ChallengeTM Season 6, including its accompanying series of roadshows and other engagement activities.
- 43. The Terms and Conditions shall be governed by the laws of Singapore. The Terms and Conditions shall constitute the entire understanding and agreement between the HPB and the Participants. The Terms and Conditions are not intended to confer rights on any third-party cap, whether pursuant to the Contracts (Rights of Third Parties) Act (Cap. 53B) or otherwise, and no third party shall have any right to enforce any provision of the Terms and Conditions.
- 44. In any term or provision of the Terms and Conditions is held to be illegal or unenforceable, such term or provision shall be deemed to be deleted from the Terms and Conditions and the validity or enforceability of the remainder of the Terms and Conditions shall remain in full force and effect. HPB's failure to enforce at any time the provisions of the Terms and Conditions or any rights in respect thereto shall in no way be considered to be a waiver of such provisions, rights, or elections or in any way affect the validity of the Terms and Conditions.
- 45. In the event of any inconsistency between the Terms and Conditions and any brochure, marketing or promotional material relating to challenge, the Terms and Conditions shall prevail.
